**PROPOSED BUDGET OF EXPENDITURES TOGETHER WITH TAX LEVY FOR FISCAL YEAR BEGINNING JULY 1, 2016 TO AND INCLUDING JUNE 30, 2017**

The Board of Directors of Hillcrest School District of Lawrence County, Arkansas, in compliance with the requirements of Ark. Code Ann. § 6-13-622 and Amendment 74 of the Constitution of the State of Arkansas, has prepared, approved, and does hereby make public a proposed budget of expenditures for the district in 2016-17 together with a supporting tax rate as follows:

- 1. Salary Fund Expenditures \$1,627,618
  - 2. Instructional Expense \$639,790
  - 3. Maintenance & Operation Exp. \$606,646
  - 4. Pupil Transportation Expense \$329,312
  - 5. Other Operating Expense \$360,500
  - 6. Non-bonded Debt Payment \$0
  - 7. Bonded Debt Payment \$202,245
  - 8. Building Fund Expense \$0
  - 9. Dedicated Maint. & Op. Exp. \$0
- 35.90 Total Mills School Tax

This represents no change from the previous year. The total tax levy proposed above includes 25 mills for the maintenance and operation of schools, 0 dedicated maintenance and operation mills dedicated for 0 purposes, and 10.9 mills for debt service previously voted as a continuing debt service tax pledged for the retirement of existing bonded indebtedness. The district may use surplus revenues produced each year by debt service millage for other purposes.
