It will include a page requesting that comments, questions, and suggestions be forwarded to the Federal Coordinator, Mr. Mickel Smith. He will also provide information regarding the parental involvement policy and activities during the public meeting held each fall. The district will provide, if requested by parents, opportunities for meetings to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their children, and respond to any suggestions as soon as practicably possible.

Mr. Shawn Rose, elementary principal, will coordinate parental involvement activites with those of other programs from Home Instruction Program for Preschool Youngsters and State-run preschool programs to services such as Educational Talent Search for career planning. Also private family counseling services and organizations such as the Arkansas Parent Training and Information Systems for families with disabilities will be provided.

We, as a district, will promote a smooth transition to public schools by making needed information available through open house, brochures, and other avenues. Preschool programs share their information with kindergarten teachers. Transition into college and career will be supported with the help of the school counselor. We will also encourage all parents and programs to use the resources of the Title I Parent Center. The parent center will be located in the library on each school campus. Mrs. Jeanne Clem at the elementary campus and Mrs. Sharon Oliver at the high school campus will serve as coordinator(s) of this parent center and will serve as the parental involvement contact person for each of the respective Title I, Part A schools.
